**JOIN THE 150 CLUB FOR THE CHANCE TO WIN UP TO £500

- When you become a member of the 150 Club, for as little as £12 per annum payable by Standing Order, you will be allocated a number. If your number is drawn you will win a prize of up to £500.

- Membership can be either individual or corporate.
- Individuals just need to decide how many numbers they require then complete the attached Standing Order form and return it to the address indicated.
- For corporate (Lodge) membership, the members need to agree how many numbers the Lodge should purchase and the Treasurer should complete the attached Standing Order form and return it to the address indicated.
- Printed overleaf are the rules of the 150 Club and the level of prizes that can be won at the two draws.
- All proceeds from the 150 Club will go to the South Wales Mark Benevolent Fund to aid brethren and their dependants of this Province.

150 Club Rules

1. The name of club is the '150th Anniversary 2020 Appeal 150 Club' which hereafter will be referred to as the '150 Club'.
2. The object of the 150 Club is to raise money for The Provincial Grand Lodge of Mark Master Masons of South Wales Benevolent Fund.
3. The 150 Club shall be managed by a sub-committee consisting of three brethren nominated by the Assistant Provincial Grand Master (Chairman of the 150th Anniversary 2020 Appeal) and they will report to the 150th Anniversary 2020 Appeal Committee. This sub-committee shall consist of a Chairman, Treasurer and Secretary/Coordinator.
4. The address of the 150 Club shall be that of the Mark Provincial Office, Bridgend Masonic Hall, Coychurch Road, Bridgend, CF31 2AP.
5. All applications for membership of the 150 Club shall be made in writing to the Secretary/Coordinator, whose address is shown on the application form.
6. Individual membership of the 150 Club shall be limited to brethren of this Province and their immediate families and shall be subject to the relevant legislation. Corporate membership shall be limited to Mark and RAM Lodges within the Province.
7. Membership subscription shall be at the rate of £12 per number, payable annually in advance by Standing Order. Members are free to cancel their subscription on each anniversary by prior written notice to the Secretary/Coordinator.
8. Any member whose subscription is in arrears at the time of a draw shall not be entitled to participate.
9. Subject to due payment of subscription, all members shall be entitled to take part in a bi-annual draw, to be held at the dinner after Provincial Grand Lodge and the Provincial Officer's Mess Christmas Lunch, the prizes being as described in this brochure. The first draw will take place once 100 numbers have been sold.
10. Prize winners, if not present at the draw, will be notified by post (or electronically) and the winners' names will be published on the Provincial website. Prizes will be delivered to the prize winner in person or by post.
11. An audited statement of receipts and payments will be published in conjunction with the General Accounts at the Annual Provincial Grand Lodge Meeting.
12. The decision of the Committee shall be final in any interpretation of these rules.
